

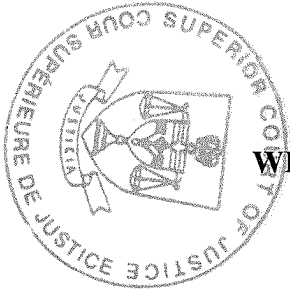

WHATSWHAT, INC., of the City of Toronto, in the Province of Ontario**

BANKRUPTCY ORDER

THIS APPLICATION of Russell Tench, a creditor of Whatswhat, Inc. in the Province of Ontario, filed on the 1st day of June, 2015 for a bankruptcy order against Whatswhat, Inc. was heard this day at 393 University Avenue, Toronto, Ontario.


ON READING the Application for Bankruptcy Order, the Affidavit of Russell Tench sworn on May 26, 2015, filed, and upon hearing from counsel to the Applicant, no one appearing for Whatswhat, Inc., although properly served as appears from the Affidavits of Service of Joanna Lewandowska sworn on May 28, 2015, and Matthew Battista sworn May 29, 2015, filed;

AND it appearing to the Court that the following act of bankruptcy has been committed:

(a) Whatswhat, Inc. has, within the six (6) months next preceding the date of the filing of the application, ceased to meet its liabilities generally as they become due;

1. **THIS COURT ORDERS** that Whatswhat, Inc., of the City of Toronto in the Province of Ontario (the "**Bankrupt**"), be and is hereby adjudged bankrupt by virtue of a bankruptcy order hereby made on this date.
2. **THIS COURT ORDERS** that Dodick Landau Inc. of the City of Toronto, in the Province of Ontario, be and is hereby appointed as trustee of the estate of the Bankrupt (the "**Trustee**").
3. **THIS COURT ORDERS** that the Trustee give security in cash or by bond or suretyship without delay, in accordance with subsection 16 (1) of the *Bankruptcy and Insolvency Act* (Canada).

4. **THIS COURT ORDERS** that the costs of the applicant creditor shall be paid out of the estate of the Bankrupt on taxation of the estate.
