

NOTICE OF MOTION

Web Offset Publications Limited ("**Web Offset**" or the "**Company**") will make a Motion to a judge on Tuesday, February 14, 2017 at 10:00 a.m., or as soon after that time as the Motion can be heard at the court house, 330 University Avenue, 8th Floor, Toronto, Ontario, M5G 1R7.

PROPOSED METHOD OF HEARING: The Motion is to be heard:

THE MOTION IS FOR

(a) an Order abridging the time for service and filing of the within Motion, declaring that service of this Motion has been validly effected on all necessary parties and declaring that this Motion is properly returnable on February 14, 2017;

- (b) an Order pursuant to s.50.4(9) of the *Bankruptcy and Insolvency Act* (the "**BIA**") extending the time in which Web Offset must file a Proposal to its creditors for a period of 23 days, from February 18, 2017 to March 10, 2017; and
- (c) an Order approving the activities of the Proposal Trustee as set out in the First Report of the Proposal Trustee, dated February 10, 2017 (the "First Report") and approving the First Report; and
- (d) such further and other relief as this Honourable Court deems just.

THE GROUNDS FOR THE MOTION ARE

- (a) Web Offset is a corporation incorporated pursuant to the laws of Ontario. Web Offset is a commercial printer and operates out of a plant located at 1800 Ironstone Manor in Pickering Ontario. Web Offset is in its 54th year of business and presently has approximately 90 employees, the majority of whom are unionized;
- (b) Web Offset is insolvent. It is currently operating under bankruptcy protection, having filed a Notice of Intention to Make a Proposal (the "NOI") pursuant to s.50.4 the *Bankruptcy and Insolvency Act* on January 19, 2017. Dodick Landau Inc. (the "**Proposal Trustee**" or "**DLI**") has been appointed as proposal trustee;

- (c) At the time of filing the NOI, Web Offset was in the process of performing the terms of a prior proposal made to its creditors and approved by the court on January 26, 2016 (the "2016 Proposal");
- (d) As a result of worse-than-expected financial performance and declining sales, it became clear that Web Offset would be unable to continue to perform the terms of the 2016 Proposal and simultaneously fund business operations from revenues;
- In consultation with its senior secured lender, Bibby Financial Services (Canada)

 Inc. ("Bibby"), DLI was retained to assist in conducting an expedited sale or investment solicitation process ("SISP") with a view to finding a purchaser for the business of Web Offset;
- (f) Throughout the SISP and to present, Bibby has been funding Web Offset's essential operating requirements, on a case by case basis, under its secured lending facility;
- (g) On January 19, 2017, Web Offset filed the NOI in response to a cash flow crisis which threatened business shutdown. Even a temporary shutdown of Web Offset's business would likely compromise Web Offset's customer base and cause irreparable damage to the value of business and any prospect of its continuation as a going concern. Web Offset was hopeful that the SISP would result in an offer to purchase on a going concern basis;

- (h) The SISP process was successful in generating an offer to purchase the business of Web Offset on a going-concern basis;
- (i) Negotiations are presently underway involving the key stakeholders in Web Offset and the proposed purchaser. These negotiations are ongoing and it is anticipated that terms of a sale transaction involving the business and assets of Web Offset will be finalized in the near future;
- (j) The proposed sale will establish the basis upon which any new proposal will be made;
- (k) The deadline by which Web Offset must file a proposal is February 18, 2017.Web Offset will not be in a position to file a Proposal by this date;
- (l) In a forced liquidation, it is not anticipated that there would be any realization available to unsecured creditors of Web Offset;
- (m) The process herein described has the support of the key stakeholders in Web Offset and its senior secured creditor, Bibby;
- (n) Web Offset seeks a 23-day extension of the time in which it must file a Proposal to its creditors from February 18, 2017 to March 10, 2017. In this regard, Web

Offset is acting and has acted in good faith and with due diligence, Web Offset

will likely be able to make a viable proposal if the extension herein applied for is

AFFIDAVIT OF JOHN BACOPULOS

I, JOHN BACOPULOS, of the City of Toronto, in the Province of Ontario, make oath and say:

1. I am the Chief Executive Officer for Web Offset Publications Limited ("Web Offset" or the "Company") and as such have knowledge of the facts to which I hereinafter depose except as where I have otherwise indicated and in which case I have indicated the source of my knowledge and belief.

BACKGROUND

2. Web Offset is a corporation incorporated pursuant to the laws of Ontario. Web Offset is a commercial printer and operates out of a plant located at 1800 Ironstone Manor in Pickering Ontario (the "**Premises**").

Attached hereto and marked as Exhibit "A" is a true copy of a corporate profile for Web Offset

3. Web Offset is in its 54th year of business and presently has approximately 90 employees, the majority of whom are members of Unifor.

4. Web Offset specializes in trade publications and prints hundreds of titles. Web Offset has a varied customer base, and produces publications such as the New England Journal of Medicine, Power Boating, CPA Magazine, Lexpert and Truck News, to name a few.

5. Web Offset produces daily, weekly, and monthly publications for its clients, with historical sales of approximately 15 million dollars annually.

INSOLVENCY OF WEB OFFSET

6. Web Offset is insolvent and is currently operating under bankruptcy protection, having filed a Notice of Intention to Make a Proposal ("NOI") pursuant to s.50.4 of the *Bankruptcy and Insolvency Act* on January 19, 2017. Dodick Landau Inc. (the "Proposal Trustee" or "DLI") has been appointed as proposal trustee.

Attached hereto and marked as Exhibit "B" is a true copy of Web Offset's Certificate of Filing and NOI package to creditors

- 7. At the time of filing the NOI, Web Offset was in the process of performing the terms of a prior proposal made to its creditors and approved by the court on January 26, 2016 (the "2016 Proposal").
- 8. As a result of worse-than-expected financial performance and a decline in sales the Company has experienced recent financial difficulties. In the fall of 2016, it became evident that Web Offset would be unable to continue to perform the terms of the 2016 Proposal and fund its business operations from revenues.

- 9. As a result, in late 2016 the Company undertook an informal sales process and approached certain industry operators to determine if such parties were interested in acquiring the Company's business.
- 10. Web Offset sought and obtained the financial support of its senior secured lender, Bibby Financial Services (Canada) Inc. ("Bibby"), to proceed with an expedited sale or investment solicitation process ("SISP").
- 11. DLI, a licensed insolvency trustee, was retained to assist with the SISP and to provide reporting to Bibby, in order to give Bibby comfort as to the process and the essential operational funding required by Web Offset during the SISP. On a case by case basis, Bibby has been funding essential operating requirements under its secured lending facility.

THE SISP

- 12. The Company and DLI identified potential purchasers and liquidators who may have interest in acquiring the business/assets of Web Offset.
- 13. On or about January 12, 2017, DLI contacted all such parties, provided them with an offer sheet, confidentiality agreement and a form of Agreement of Purchase and Sale. DLI requested that any offers be submitted by 5:00 pm on January 19, 2017 (the "Offer Date").
- 14. The SISP contemplated a target closing date of January 31, 2017.
- 15. Interested parties conducted due diligence during the following week.

FILING OF THE NOI

- 16. On January 19, 2017, as the SISP process was ongoing, Web Offset filed the NOI in response to mounting pressure from unsecured creditors and a cash flow crisis which threatened business shutdown. Even a temporary shutdown of Web Offset's business would likely compromise Web Offset's customer base and cause irreparable damage to the value of business and prospect of its continuation as a going concern. Web Offset was hopeful that the SISP would result in an offer to purchase on a going concern basis.
- 17. The purposes of the NOI were to:
 - (a) stay pending action by unsecured creditors; and
 - (b) provide an environment in which the SISP process could play out and, possibly, in which the Company could apply to the Court for approval of a sale transaction.
- 18. The NOI appointed DLI as proposal trustee.

THE GOING CONCERN SALE

- 19. Web Offset has received an offer to acquire the business of the Company on a going-concern basis.
- 20. The proposed transaction, if completed, would see the business remain on site and continue to employ the majority of the employees, including approximately 60 unionized employees (the "Going Concern Sale"). Terms of the Going Concern Sale continue to be negotiated but the parties are optimistic that these will be finalized in the near future and that the Going Concern Sale will proceed.

- 21. The Company and Bibby, are of the view that the Going Concern Sale represents the best result for the Company and its stakeholders including, without limitation, Bibby and the Company's employees. Accordingly, the parties agreed to move forward with the Going Concern Sale.
- 22. The Going-Concern Sale includes certain conditions, such as:
 - (a) agreement with the employee's union (the "Union");
 - (b) reaching satisfactory agreements with certain suppliers;
 - (c) a transfer of the Premises lease; and
 - (d) the issuance of an approval and vesting order in respect of the sale.
- 23. Satisfying these conditions required that the target closing date be pushed back. As at the date hereof, the majority of the conditions have been satisfied or waived (including the agreement with the Union).
- 24. The purchaser is, however, still finalizing the terms of the transfer of the Premises lease with the Company's landlord, HOOPP Realty Inc. (the "Landlord"). As a result, the Company will not be able to complete the Going Concern Sale or make a proposal before the stay under the NOI expires.

REQUEST FOR EXTENSION

25. The proposed Going Concern Sale will establish the basis upon which any new proposal will be made. If the extension herein is not granted, no proposal will be possible and the Company will be deemed bankrupt, to the detriment of all creditors and stakeholders in the Company.

- 26. In a forced liquidation, it is not anticipated that there would be any realization available to unsecured creditors of Web Offset.
- 27. The process herein described has the support of key stakeholders in Web Offset, being its senior secured creditor, Bibby, its Landlord and the Union.
- 28. Web Offset seeks a 23-day extension of the time in which it must file a Proposal to its creditors from February 18, 2017 to March 10, 2017. In this regard, Web Offset is acting and has acted and continues to act in good faith and with due diligence in respect of its operations and dealings with creditors, its dealings with the Proposal Trustee and the SISP. Web Offset will likely be able to make a viable proposal if the extension herein applied for is granted and no creditor of Web Offset will be materially prejudiced if the extension being applied for is granted.
- 29. This Affidavit is sworn in support of Web Offset's request for an extension of the time for filing a Proposal as herein referenced and for no other purpose.


