

## IN THE MATTER OF THE RECEIVERSHIP OF GREENCORE COMPOSITES INC.

Notice and Statement of the Receiver

(Subsection 245 (1) and 246 (1) of the Bankruptcy and Insolvency Act)

### THE RECEIVER GIVES NOTICE AND DECLARES THAT:

- 1. On April 16, 2018 Dodick Landau Inc. was appointed as private receiver (the "Receiver") in respect of the assets of Greencore Composites Inc. pursuant to a security interest held by Wayne Maddever, Ian Inch and Growthworks Commercialization Fund Ltd. (the "Lenders") that encumbers the assets, property and undertaking of the Debtor (the "Assets" or "Property"). The Security was registered on May 16, 2017 as financing statement No. 727698843 pursuant to the Personal Property Security Act (the "Security") and in accordance with the terms of the General Security Agreements between the Lenders and the Debtor.
- 2. Following the appointment of the Receiver, the Receiver took possession of the Assets. The Receiver notes that the Assets consist primarily of manufacturing equipment and intellectual property.
