4. That the Applicant is an unsecured creditor of the Debtor.
5. That Dodick Landau Inc., of the City of Toronto, in the Province of Ontario, is qualified to act as trustee of the property of the Debtor, has agreed to act as such, and is acceptable to the Applicant.
