BANKRUPTCY ORDER

Upon the application of ZCS Akia Engineers Inc. (“ZCS”), a creditor, issued on the 4th day of July, 2024, and upon reading the Application for Bankruptcy Order, the Affidavit of Sumeru Kumar sworn the 17th day of September, 2024 and the exhibits thereto, the Affidavit of Rajesh Nayyar sworn the 10th day of September, 2024 and the exhibits thereto, the Affidavit of Sumeru Kumar sworn the 4th day of July, 2024 and the exhibits thereto, and the Consent of Dodick Landau Inc. to act as trustee of the property of Attesta International Safety Certification Inc. (the “Debtor”) dated the 3rd day of July, 2024, and it appearing to the Court that the following acts of bankruptcy have been committed:

- a) the Debtor ceased to meet its liabilities generally as they became due, in that it has failed to pay its obligations to the applicant creditor, ZCS.

1. **THIS COURT ORDERS** that the Debtor be adjudged bankrupt, and a bankruptcy order is made against the Debtor on this date.

2. **THIS COURT ORDERS** that Dodick Landau Inc., of the City of Toronto, in the Province of Ontario, be appointed as trustee of the estate of the bankrupt Debtor (in such capacity, the “Trustee”).

3. **THIS COURT ORDERS** that the Trustee give security in the amount to be fixed by the Official Receiver pursuant to subsection 16(1) of the *Bankruptcy and Insolvency Act* (Canada).
