[Negative market conditions] The company experienced a prolonged period of insufficient sales volume, resulting in an inability to generate adequate revenue to cover ongoing overhead expenses and operational costs, ultimately leading to a severe liquidity crisis and insolvency. The company also suffered a significant financial impact relating to delays and deficiencies in the supply and installation of its refrigeration equipment. The supplier subsequently became insolvent, limiting the company's ability to recover its losses.
